

Look 2 Consulting, LLC – End User License Agreement

Carefully read this End User License Agreement (the “Agreement”), which governs your use of any or all of the Software or Services offered by Look 2 Consulting, LLC (“Look2”). By downloading the Software and/or completing the installation process, you (“Licensee”) agree to be bound by the terms of this agreement by and between you and Look2 (“Licensor”), and you acknowledge that this Agreement is enforceable like any written negotiated agreement signed by you.

If you do not want to become a party to this agreement, do not install or use the Software. Instead, return the Software within 30 days of receipt. All returns will be subject to the Licensor's return policy.

Whereas, Licensee desires to license Software for purposes of helping improve its operations and Look2 wishes to license Software to Licensee. Now, therefore, Licensor and Licensee agree as follows.

1. Software Defined. The “Software” means: (a) all of the contents of the downloadable or otherwise transferred files, disks, and other media for any of the modules offered by Licensor (e.g., *Look2 Inventory, Look2 Volunteers, Look2 Registration, Look2 Donor*); (b) all related documentation, manuals, videos, and instructions; (c) all Updates (as the term is defined below); (d) your use of all of the above.

Furthermore, “GUI” means: the front-end programs which are part of the Software, containing the main code for the Graphical User Interface (e.g., *Look2_Inventory_GUI.accd*, *Look2_Volunteers_GUI.accd*, etc.); and “Macro Reports” means: the Microsoft Excel report templates which are part of the Software, containing coded macros provided by Licensor.

2. Ownership. The Software, and any and all copies made by Licensee, including without limitation, the trademarks, copyrights, software, graphics, and the like, is owned by or licensed to Look2 and is subject to trademark, copyright and other intellectual property laws of the United States and foreign countries, and remains the property of Licensor. You acknowledge that Look2 owns all title, rights and intellectual property in the Software, except Third Party Software (as defined below).

3. License Terms. Licensor grants to Licensee a non-transferable, non-exclusive, non-sublicensable, non-assignable, revocable limited license to use the Software in accordance with the terms of this Agreement.

- a. Each PC running the Software’s GUI must have its own License. If a PC is only running the Macro Reports in order to generate reports, that PC need not have its own License.
- b. Licensee may use the Licensed Software for its own use within Licensee’s business operations
- c. Licensee may not, except as authorized by this Agreement, do any of the following:
 - i. license, distribute, sublicense or otherwise commercially exploit the Software except as authorized by this Agreement
 - ii. copy, modify or translate the Software or incorporate them into other software
 - iii. disassemble, reverse engineer or decompile the Software or otherwise attempt to discover any portion of the source code related to the Software
 - iv. create any copies or derivative works regarding the Software

- d. You understand and agree that you have no interest, monetary or otherwise, in any feature or content contained in the Software, including without limitation, any suggestions for improvement you provide to Look2.
- e. You understand and agree that Look2 has the right to audit your use of the Software from time to time to ensure your adherence to the License requirements and the terms of this Agreement.

4. Third Party Software. Certain items of the Software may be owned by third parties (“Third-Party Software”) and be subject to third party licenses, including “open source” licenses, in addition to being subject to this Agreement. Furthermore, the software is built using Microsoft Access and Excel.

LOOK2 MAKES NO REPRESENTATION, WARRANTY OR OTHER COMMITMENT OF ANY KIND REGARDING SUCH THIRD-PARTY SOFTWARE, ITS CONTINUED MAINTENANCE, OR SUPPORT. LOOK2 SHALL, TO THE MAXIMUM EXTENT PERMITTED BY LAW, HAVE NO LIABILITY ASSOCIATED WITH ITS USE OF THIRD-PARTY SOFTWARE.

5. Access and Use of Software. You are solely responsible for maintaining the confidentiality and security of any passwords used by you to access the Software and/or administrative features within the Software, and for preventing unauthorized access to or use of the information, files or data that you store or use in or with the Software. To the extent permitted by applicable law, you shall be solely responsible and liable for your use of the Software and for all activities that occur.

6. Backup of Software and Data. Licensee may make copies of the Licensed Software for archival purposes or for backup, as necessary. You are solely responsible and liable for backing up not only the Software as supplied by Look2, but also your customized configuration and subsequent data collected via the Software.

7. Fees. In consideration for your License of the Software, including any related support and maintenance services, you will pay to Look2 any license fees and service fees identified when you obtain the Software or Service or in your software order. License fees may be imposed or adjusted by Look2 in its sole discretion. Invoices will detail any charges for software upgrades and the fees related thereto will be payable by you unless you notify Look2 in writing within fourteen (14) business days of your receipt of an invoice of your desire to opt-out of any such upgrade and specifically identify the upgrade in such writing. Invoices are payable upon receipt. Invoices not paid in thirty (30) days from the date of invoice are subject to interest charges stated on the invoice. If you fail to pay any fees in a timely manner, Look2 may (reserving other legal remedies and rights) terminate this Agreement without further notice.

8. Software Updates and Access. Look2 has the right to, but not the obligation to, create and apply patches, updates and modifications to the Software (each an “Update”) at any time for any reason, including to update and maintain it and to address errors or interruptions; and functionality may change after an Update. Look2 has the right, in its sole discretion, to impose limits on certain features or restrict your use of parts or all of the Software or Service without notice or liability, temporarily or permanently. Look2 reserves the right to make any such Updates effective immediately to maintain security, to comply with any laws or regulations, or for any other reason it deems appropriate. Your continued use of the Software will constitute acceptance of and agreement to such Updates. Maintenance upon the Software may be performed from time to time resulting in interrupted service,

delays, or errors in the Software or Service. You acknowledge and agree that Updates may be incompatible with previous software versions, could include substantial changes to the system, and that data collected or created using one version of the Software may not be available in subsequent versions. Look2 makes no representation that the Software, Service or Updates will work on a particular device. You are responsible for having necessary Internet connections, equipment, software and services for you to effectively access the Website, download and use the Software, Updates, and Services.

9. Collection and Use of Information.

- a. You acknowledge and consent that Look2 may, directly or indirectly through the services of others, collect and store information about you, about your use of the Software, Services and Website, and about the equipment on which the same is installed, accessed or used. Such information may include personally identifiable information about you such as your name, contact information, age, and gender, as well as data collected from use of the Software, Services and Website. You agree that Look2 may use such information for any purpose related to any use of the Software, Services and Website, by you, including but not limited to: (i) improving the performance of the Software, Services and Website, or developing Updates, (ii) verifying compliance with terms of this Agreement and (iii) enforcing Look2's rights, including all intellectual property rights in the Software, Services and Website.
- b. You agree that Look2 may send you messages, alerts, and other communications through the Website, Software and Service, including through email, text message and other similar means in accordance with the preferences you set, and you agree to accept such messages, and pay any applicable network access, data usage, or similar fees.
- c. You acknowledge and consent that Look2 may from time to time identify you and certain of its other customers or licensees as being users or Licensees of the Software or Services. For example, Look2 may be asked by potential customers about the types of users or identity of users of the Software or Services, and you consent that Look2 may respond to this type of inquiry to identify certain exemplary organizations or Licensees that use the Software or Services.

10. No Warranties. YOU ACKNOWLEDGE THAT THE SOFTWARE, SERVICE AND WEBSITE IS PROVIDED "AS IS," AND WITHOUT ANY REPRESENTATIONS OR WARRANTIES OF ANY KIND. ALL WARRANTIES, CONDITIONS, REPRESENTATIONS, INDEMNITIES AND GUARANTEES WITH RESPECT TO THE PRODUCTS, WHETHER EXPRESS OR IMPLIED, ARISING BY LAW, CUSTOM, PRIOR ORAL OR WRITTEN STATEMENTS BY LOOK2, ITS AGENTS OR OTHERWISE (INCLUDING, BUT NOT LIMITED TO ANY WARRANTY OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, TITLE OR NON-INFRINGEMENT) ARE HEREBY OVERRIDDEN, EXCLUDED, AND DISCLAIMED.

11. No Consequential Damages. UNDER NO CIRCUMSTANCES WILL LOOK2 BE LIABLE FOR ANY CONSEQUENTIAL, INDIRECT, SPECIAL, PUNITIVE OR INCIDENTAL DAMAGES OR LOST PROFITS, WHETHER FORESEEABLE OR UNFORESEEABLE, BASED ON YOUR CLAIMS OR THOSE OF THIRD PARTIES (INCLUDING, BUT NOT LIMITED TO, CLAIMS FOR LOSS OF DATA, GOODWILL, USE OF MONEY, INTERRUPTION IN USE OR AVAILABILITY OF DATA, STOPPAGE OF OTHER WORK OR IMPAIRMENT OF OTHER ASSETS), ARISING OUT OF BREACH OR FAILURE OF EXPRESS OR IMPLIED WARRANTY, BREACH OF CONTRACT, MISREPRESENTATION, NEGLIGENCE, STRICT LIABILITY IN TORT OR OTHERWISE. YOU ASSUME TOTAL

RESPONSIBILITY AND RISK FOR YOUR USE OF THIS SERVICE, THE WEBSITE, SERVICE AND THE INFORMATION RECEIVED THROUGH IT. FURTHER, LOOK2 MAKES NO REPRESENTATIONS WHATSOEVER ABOUT OTHER WEBSITES WHICH YOU MAY ACCESS THROUGH ITS WEBSITE OR THE SOFTWARE, SERVICES OR PRODUCTS CONTAINED THEREIN OR OBTAINED THERE THROUGH. LOOK2 FURTHER DOES NOT WARRANT THE QUALITY, VALIDITY, ACCURACY OR COMPLETENESS OF THE MATERIALS OR THAT THE FUNCTIONS CONTAINED ON THE WEBSITE, SERVICE AND/OR SOFTWARE WILL BE UNINTERRUPTED OR ERROR-FREE, OR THAT DEFECTS OR INACCURACIES WILL BE CORRECTED. INFORMATION PUBLISHED AT THE WEBSITE OR IN CONNECTION WITH THE SERVICE OR SOFTWARE MAY REFER TO PRODUCTS, PROGRAMS OR SERVICES THAT ARE NOT AVAILABLE. YOU HEREBY RELEASE LOOK2 FROM ANY AND ALL CLAIMS, DEMANDS AND DAMAGES, KNOWN OR UNKNOWN, SUSPECTED OR UNSUSPECTED, DISCLOSED OR UNDISCLOSED, ARISING OUT OF OR IN ANY WAY RELATED TO A DISPUTE BETWEEN YOU AND ANOTHER ACCOUNT HOLDER.

CALIFORNIA RESIDENTS HEREBY SHALL AND DO WAIVE CALIFORNIA CIVIL CODE 1542, WHICH PROVIDES "A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."

LOOK2 AND ITS MEMBERS, DIRECTORS, OFFICERS, EMPLOYEES AND AGENTS AND ITS AFFILIATES ARE NEITHER RESPONSIBLE NOR LIABLE FOR ANY DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, EXEMPLARY, PUNITIVE OR OTHER DAMAGES, INCLUDING INTERRUPTION OF BUSINESS, ARISING OUT OF OR RELATING IN ANY WAY TO THE SERVICE, ITS WEBSITE, AND/OR SOFTWARE OR ANY INFORMATION RECEIVED FROM THE SAME, INCLUDING THE CONTENT OR ANY INFORMATION CONTAINED WITHIN OR THROUGH THE WEBSITE, SERVICE AND/OR SOFTWARE. YOUR SOLE REMEDY FOR DISSATISFACTION WITH THE SERVICE, WEBSITE AND SOFTWARE IS TO TERMINATE YOUR ACCOUNT AND/OR STOP USING THE WEBSITE, SERVICE, SOFTWARE, AND THE INFORMATION OBTAINED THEREIN. NOTWITHSTANDING THE FOREGOING, UNDER NO CIRCUMSTANCES WILL LOOK2'S LIABILITY TO LICENSEE EXCEED THE AMOUNT PAID BY LICENSEE FOR THE SOFTWARE, SERVICES OR FOR THE USE OF THE SOFTWARE WITHIN THE LAST TWELVE MONTHS.

13. Indemnification. You agree to indemnify, defend, and hold harmless Look2, its subsidiaries, affiliates, officers, directors, employees and agents from and against all allegations, claims, demands, losses, expenses, damages, costs, including reasonable attorneys' fees, arising in connection with your or any of your patients, customers or clients': (i) use of the Software, Service and Website, and (ii) violation of this Agreement or any rights of another person or entity.

14. Termination. Either party (Look2 or you) may terminate this Agreement and your License to use the Software and Service at any time, for any reason, with or without cause. Upon termination, all rights granted to you hereunder will cease, and you will promptly purge the Software from your computers and immediately cease using such Software and Service. All provisions of this Agreement which by their nature extend beyond termination will survive termination, including any payment obligations for amounts still owed by you to Look2 at the time of termination. In the event that you

terminate or breach this Agreement, you will forfeit your right to any and all purchases of Licenses and other payments made in connection with the Software, Service and Licenses. A termination of this Agreement will also act to terminate your License. You acknowledge and agree that you are not entitled to any refund for any amounts paid or pre-paid in connection with the Account prior to termination of this Agreement.

15. Amendments to Agreement. Look2 may update and amend this Agreement at its sole discretion (each an "Amendment"), and you may be asked to review and agree to a revised version. If you do not agree to the revised version of this Agreement, you will not be permitted to continue use of your License, Account, Software or Service. If at any time you become no longer able to comply with the terms of the current version of this Agreement, you must terminate this Agreement and immediately stop using any License, Software and Service. You acknowledge and agree that you are not entitled to any refund for any amounts paid or pre-paid in connection with the Account prior to termination of this Agreement.

16. Governing Law, Jurisdiction & Venue. This Agreement shall be governed by and construed in accordance with the laws of the State of Wisconsin. You hereby consent to the exclusive jurisdiction and venue of the federal and state courts of the State of Wisconsin, located in Madison, Wisconsin, for all purposes in connection with any action or proceeding which arises out of or relates to the resolution of any disputes relating to this Agreement, the relationship between Look2 and you, and the Software, Service, Website and Updates.

17. Severability. The provisions of this Agreement are severable, and if any one or more such provisions shall be judicially determined to be illegal or otherwise unenforceable, in whole or in part, the remaining provisions or portions of this Agreement will nevertheless be binding on and enforceable by and between Look2 and you.

18. No Waiver. The failure of Look2 to enforce this Agreement for breach or nonperformance shall not operate as a waiver of any rights to enforce the Agreement or invoke any other remedy for subsequent breach or nonperformance.

19. Assignment. You may not assign, delegate or otherwise transfer this Agreement or any of its rights or obligations hereunder without Look2's prior written approval. Look2 may assign this Agreement or any of its rights or obligations to a related party or pursuant to a sale, merger, or other consolidation of Look2. You consent in advance to any such assignment.

20. Entire Agreement. The current version of this Agreement constitutes the complete and exclusive expression of the understandings and agreements of the parties relating to the subject matter hereof, and supersedes all prior agreements, understandings and negotiations, whether written or oral, between the parties relating to such subject matter, including, but not limited to the Privacy Policy and Terms of Use of the Software.
